PARENT/GUARDIAN CONSENT AND AGREEMENT

I am requesting that the named participant be admitted to Triple C Camp, with the understanding if programs or buses are full I will be registered and wait listed as space allows. I give permission for the named person to participate in ALL aspects of camp, including Charlottesville's Challenge Course on the grounds of Triple C Camp, to go on trips outside of the camp facility, to be transported in vehicles operated, or contracted, by the camp, to be included in photos or videos for promotional use by Triple C Camp, the American Camp Association (and their agents), and to have sunscreen applied. <u>I understand that the</u> Commonwealth of Virginia mandates 1) a physical/well child check up that is within two years of the last date your child(ren) will be attending camp (must be signed by a doctor), 2) a copy of child's immunization records 3) a copy of child's birth certificate or passport, 4) a signed Non-prescription for Over-the-Counter Skin Products Authorization Form and if needed, 5) a medication authorization form must be submitted to attend summer camp. These forms must be submitted at least one week before camp begins in order for child to attend. In the event that I cannot be reached in an emergency involving the above named participant, I hereby give permission to the appropriate medical personnel, selected by Triple C Staff, to provide medical treatment deemed necessary by such personnel. I agree to be responsible for all charges incurred in the treatment of the participant regardless of whether my insurance covers such charges. I understand that I will pick up my child as soon as possible, if notified by Triple C Camp that they have become ill while at camp. I will inform Triple C Camp within 24 hours or by the next business day if any member of the household has developed any reportable communicable disease, as defined by the State Board of Health, except for life threatening diseases which must be reported immediately. I understand communicable disease risks. I understand activities on the camp property involve risk. I agree not to hold camp liable for injuries sustained during programs. I understand that I am responsible for payment of all programs, and that payment will be made to Triple C Camp by noon, the Friday <u>BEFORE</u> each week of registration. The full tuition for all programs registered will be paid, regardless if the named participant attends. Initial Payment with registration is not refundable, not transferable and is applied to the last week enrolled. If paying by credit card a 4% additional charge will be applied to your account. Triple C Camp reserves the right to cancel programs, in which case registration payments will be returned. There will be a \$100 fee charged for each returned check, change of registration (There is no refund made for cancellations), late payment or other administrative changes. I authorize an auto draft from any methods of payment previously used for tuition and/or fees after the due date and time. Any change request to initial registration must be made <u>in writing</u> by family and approved by camp administration. Triple C Camp offers an optional weekly refund protection for a fee of \$75 per week. Refund protection entitles you to a full refund of all camp fees for the specific week protected, if you cancel. Cancellations must be received, in writing, 5 business days prior to the start of the camp week. The refund protection fee is due at the time of registration and is non-refundable. Once you have enrolled in refund protection, the fee of \$75 may not be transferred to any other week(s). Refunds will not be available to those not enrolled in refund protection. All participants are expected to follow the program schedule for which they are enrolled. All participants are expected to come prepared with snacks and a lunch. If a camper does not bring their lunch, camp will provide them one and a \$10 charge will be added to and processed on the family account using the most recent payment method on file. Triple C Camp requests that insect repellent stay home. This is based on Virginia Child Care Licensing Standards requiring repellent be inaccessible to children (Standard 8VAC20-780-520). If you require your camper to put on insect repellent during the camp day, please email and we will create a plan to support your camper. The Directors reserve the right to dismiss any participant who violates camp rules or is judged detrimental to the general welfare of programs. No refund will be made in case of dismissal. I have read and agree to abide by the policies as written on this registration and included in confirmation materials. I acknowledge this to be a legal and binding contract. I understand confirmations will be emailed (or mailed) along with additional policies and other pertinent information for which I will be responsible to read, and to provide additional documentation for my child accordingly.
